


The ABAS Law Foundation congratulates the 2024 Scholarship Recipients



Tiffany Charvet earned a B.A. in International Relations and Government with honors from Claremont McKenna College, complemented by a Legal Studies sequence. She is currently pursuing a Juris Doctor degree at UC Davis School of Law. At just 16, she cofounded Share and Care Foundation Corp., a nonprofit dedicated to providing essential resources to marginalized communities, with inclusivity at its core. During her college years, Tiffany championed the Bluebook Public Access Initiative and coled the inclusive pronoun initiative during her externship with Chief Justice González at the Washington Supreme Court. In law school, she founded iConnect to support immigrants and second-generation immigrant law students and serves on RROC's voting board, which funds events hosted by historically underrepresented campus groups like the Asian Pacific Islander Law Student Association (APALSA) and the Filipino Law Student Association (FLSA). After graduation, Tiffany aspires to clerk for a judge while actively engaging in judicial outreach programs to contribute to her community.



Angela L. Valenzuela is a rising 4L at Lincoln Law School of Sacramento and full time law clerk at Hiroshima Daggett in Rancho Cordova, CA. She and a small group of students reinstated Lincoln's chapter of the Asian Pacific American Law Student Association in hopes of creating a community to support Asian American/Pacific Islander law students on campus. Angela has participated in many local events, and is a member of various organizations, namely the Asian/Pacific Bar Association of Sacramento, the Sacramento Filipino American Lawyers Association, Women Lawyers of Sacramento, and the Sacramento County Bar Association. In 2023, she was awarded "Best Brief" in Moot Court. This summer, Angela will be an extern under Presiding Justice Laurie Earl at the Third District Court of Appeals.
